6. Mode of Selection

: Selection shall be made on the basis of Written Test examination comprising of one paper in English language (Essay, Grammar and translation from English to Hindi and vice-versa). The candidates, who will be declared qualified in English language paper will be called to appear for typing test @ 30 w.p.m. in English. The short listed candidate would also undergo an interview (The candidates will have to arrange their own Type Writers for taking the test)

7. Period of Probation : One Year

8. **How to Apply**

- a) A fee of Rs. 200/- in the case of Unreserved category and Rs. 100/- in the case of reserved categories will be charged. The examination fee will be accepted by means of a **Bank Draft/Banker's Cheque only** drawn on any scheduled bank in Delhi and payable in favour of **The District & Sessions Judge, Tis Hazari Courts, Delhi. The applicant should attach attested copies of all the testimonials including SC/ST/OBC/PH category certificate.**
- b) Serving Government employees should send their applications through proper channel.
- c) The candidates shall appear in the Written Test / Typing test and interview at Delhi at their own expense. No T.A./D.A. will be paid. The dates for holding the test and interview will be intimated later on. Admit Cards for appearing in written examination will be sent only under postal certificate.
