
**ORDER**

The above mentioned Judicial Officers shall hold the courts in their respective court rooms and shall be assisted by their own staff.


The office of the court will remain open daily from 10:00 am to 5:00 pm except on Second Saturday, Sunday and other holiday, if any.
