 - The Principal District & Sessions Judge, Shahdara, KKD shall assign sufficient number of cases to the newly created court of Civil Judge-02 and Civil Judge-03 on withdrawal from the other existing courts so as to ensure equal pendency.
- 6. The court of MM-12, South-West, Dwarka, hitherto presided over by Ms. Surbhi, is abolished. The Principal District & Sessions Judge, South-West, Dwarka shall assign the cases of PS Jaffarpur Kalan to MM-9, South-West, Dwarka.
- 7. The Judicial Officers posted as Metropolitan Magistrate (Reliever) [MM (Reliever)] shall be assigned task of link duty_i TIP, inquest proceedings, recording statement under Section 164 Cr.P.C besides administrative duties.
- 8. The court of MM (Mahila Court), North-East, KKD presently presided over by Ms.Vijayshree Rathore is re-designated as MM (Mahila Court)-01, North-East, KKD.
- 9. The Principal District & Sessions Judge, North-East, KKD shall, while making compliance with the directions in Note No.15 of the Transfer Order No.12/DHC/Gaz/G-7/VI.E.2(a)/2019 dated 26.03.2019, withdraw sufficient number of cases from the existing court of MM (Mahila Court) and assign them to the newly set up MM (Mahila Court)-02 in order to ensure equitable distribution of workload.
