It is to humbly inform that consequent upon completion of 4 weeks mandatory Orientation Course of newly promoted officers of DJJS, it has been directed by Hon'ble High Court of Delhi to put the aforesaid trainee officers on Court attachment in District Courts till the resumption of their regular posting orders.

Therefore, it is requested that the promoted Officers of DJJS (under training) may kindly be attached as per schedule enclosed as Annexure 'A' to 'D' w.e.f. 12th July, 2022 to 20th July, 2022 or till they get their regular postings, whichever is earlier, by Physical/ Virtual mode. The Mentor Judicial Officers may be directed to share the Video Conferencing Link of their court proceedings with the Trainee DJJS Officers if they would be holding the court through virtual mode.


