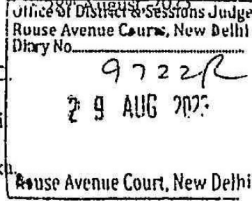

In case the Mentor Judicial Officer is transferred, the DHJS Officer may be attached with the successor Judicial Officer.
