Further, the aforesaid 73 trainee DJS Officers have been asked to assemble in Room No. 302, 3rd Floor, Tis Hazari Courts during the aforesaid period of attachment, in the batches, as per enclosed list Annexure 'C', for preparation of their Service Books. It is, therefore, requested that the concerned official of the Accounts Branch (Central) may be directed to assist them for the aforesaid purpose.
