Civil Judge, Ms. Jyoti Nain. Ld. MM-07, Sh. Ajay Narwal, Ld. MM-02 and Ms. Preeti, Ld. MM (Mahila Court-02) may be utilized by deploying them on monthly rotational basis, in the following manner:-
