It is hereby informed that to facilitate litigant/lawyers and to avoid technical problems faced by the lawyers/litigants in joining the virtual courts, a unique hyper link of each court functioning at RADC has been created through unique court ID on Cisco Webex Meeting App under Delhi District Court domain. Hyper link shall be flashed on the official website of Delhi District Court and from Tuesday onward all the courts shall virtually take their cases only through their unique ID under Delhi District Court domain on Cisco Webex Meeting App. for **uninterrupted** proceedings. Court wise link and other detail which will be flashed on the website are enclosed as "Annexure A".

In this regard, all the Judicial Officers posted in RADC are requested to direct their concerned staff to use only the unique ID created for his/her Court for the virtual court proceedings so that those litigants/lawyers whose case is pending before the court concerned may easily join the court proceedings through the URL flashing on the official website of the Delhi District Court.
