

It is hereby notified for general information of all concerned that the District Courts (except the Courts of Judicial Magistrates of First Class) in Delhi will remain closed for Summer Vacation from Monday, 16th June 2025 to Monday, 30th June 2025 (both days inclusive) and for Winter Vacation from Saturday, 27th December 2025 to Wednesday, 31st December 2025 (both days inclusive).

A period of 30 days from 01st June 2025 to 30th June 2025 is declared as the month of vacation for the year 2025 for the members of Delhi Judicial Service under the Delhi Judicial Service (Leave) Rules, 2011. Courts presided over by the officers of Delhi Judicial Service (except Courts of Judicial Magistrates of First Class) shall, however, remain closed for Summer Vacation from 16th June 2025 to 30th June 2025 (both days inclusive) and the Courts of Judicial Magistrates shall remain closed for Summer Vacation from 16th June 2025 to 25th June 2025 (both days inclusive).
