

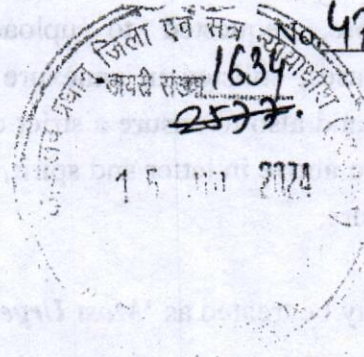

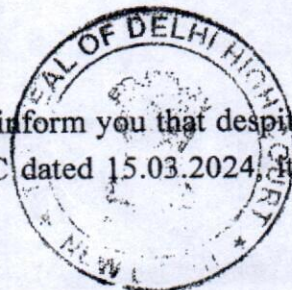

It has come to the notice that, despite issuance of requisition letter well in time, inconvenience with regard to LCRs/TCRs is being caused to the Hon'ble Courts because of the following reasons:-

- a) The LCR/ TCR are not uploaded on the portal before the next date of hearing, resulting into issuance of reminders/ unnecessary follow-ups, and unwarranted dates being issued only for want of properly bookmarked/indexed/paginated LCR/TCR.
- b) The LCR/ TCR often gets uploaded either just before the date of hearing or on the date of hearing itself, even though the requisition for the same is sent well before the time, resulting into non- availability of LCR/TCR for perusal of the Hon'ble Courts on the date of hearing.
- c) The records, being uploaded on the link/URL, are often not bookmarked/paginated/indexed which also results into a lot of inconvenience to the Hon'ble Courts.
