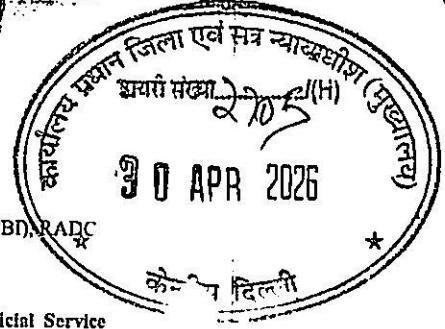

As per the directions of the Hon'ble High Court of Delhi, upon completion of the Four Weeks Foundation Course by Newly Recruited Officers of the Delhi Higher Judicial Service (DHJS), the said Officers are required to be placed on Court attachment in the District Courts until their regular postings are made by the Hon'ble High Court.

Accordingly, it is requested that the newly recruited officers of DHJS may kindly be attached with Courts as per schedule enclosed as Annexure 'A' as per the period mentioned against their name or till they get their regular posting, whichever is earlier.

The Mentor Judicial Officers be also requested to interact and suitably guide the Trainee Judicial Officers about the issues and challenges faced by them in their respective jurisdictions.

If the Mentor Judicial Officer with whom the Trainee DHJS Officer has been attached, happens to be on leave or is unavailable due to any administrative/ancillary reason, the trainee Officer may kindly be attached with the Link Officer/another Judicial Officer of similar jurisdiction in your district. In case the Mentor Judge is transferred, the trainee Officers may be attached with the successor Judge. In such an eventuality, copy of the order of attachment may kindly be sent to the Academy for information and record.
