The nominated Judicial Officers may kindly be advised not to list any judicial work on 26th September, 2026 so that litigants and lawyers are not inconvenienced. In case some judicial work has already been listed, it may be preponed or adjourned accordingly, to the extent possible.

It is further requested that the nominated Judicial Officers be instructed to ensure their mandatory attendance and punctuality. The attendance record shall be submitted to the Hon'ble High Court of Delhi upon conclusion of the programme.

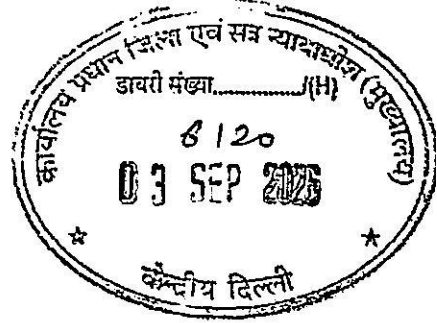
