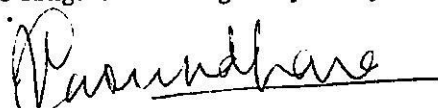
WEEKEND TRAFFIC COURTS ROSTER (WEST) DISTRICT

Note :

1. The Ld. Judicial Officer, West District, Delhi deputed for "Weekend Traffic Courts" West District, Delhi shall be assisted by her/his own court staff (01 Reader/Ahlmad, 01 Stenographer, 01 Orderly/Peon).
2. The Ld. Judicial Officer, West District, Delhi deputed for Weekend Traffic Courts, West District, and the staff of their courts shall be entitled to compensatory leave on a working day, to be availed within a period of 1 year and 06 months respectively from the date of duty.
3. The Ld. Judicial Officer, West District, Delhi deputed for Weekend Traffic Courts, West District, Delhi are directed to submit a weekly disposal report to the office of the undersigned indicating the number of cases listed, number of cases disposed, amount of fine collected etc, in the prescribed format as followed in the ECTC. The Reader/Ahlmad attached with Ld. Judicial Officer shall keep the disposed challan and consign the same to Record Room.
4. The Reader/Ahlmad, Sr. PA/PA attached with the Presiding Officer shall ensure timely updation of proceedings and disposal of challans on CIS/e-Challan Portal on the same day, so as to maintain accuracy of record and real time status of case/challan.
5. Change of duty shall be done only in exceptional cases, subject to an intimation/request being sent by the concerned Judicial Officer, at least a week before the requested change. The concerned Judicial Officer shall herself/himself arrange for an alternative and seek consent of such Judicial Officer, before sending a request for change of duty. The office of undersigned shall not be obligated to change duty in any other case.

6. The DCP, Traffic (West) Delhi is directed to depute/deploy one(01) Compounding Officer deployed in each Weekend Traffic Courts, West District, Delhi on the aforesaid said dates for verification of challans, for registration of the same in the register, for compounding the challans etc.
