CIRCULAR

It has come to the notice of the Court Authority that many old, abandoned, or unattended vehicles are lying parked in the basements and other parking areas of the Saket Courts Complex. Such vehicles pose a significant security threat to the Court Complex and its occupants.

All concerned individuals are hereby directed to remove their respective vehicles from the basements and other parking areas of the Saket Courts Complex within five days from the issuance of this order as per lists enclosed (Annexure "A", Annexure "B" and Annexure "C").

If any vehicle remains unattended or is not removed within the stipulated five days period, it shall be removed by the Security/concerned Police Department without further notice. The Court Authority will not be responsible for any damage or loss incurred during such removal. It is further directed that no vehicle (except Government Vehicles) is allowed to be parked beyond permissible hours in the Court premises.

This is issued with the prior approval of the Ld. Principal District & Sessions Judge (South), New Delhi in accordance with the directions of Hon'ble High Court of Delhi issued vide order No. 9804/DHC/Mgt. & Coord. Cell-I/BMCC (District Courts) Dated 28.05.2025 and its subsequent letter no. 778/DHC/Mgt. & Coord. Cell-I/BMCC (District Courts) Dated 27.09.2025.


