Rest of the conditions shall remain unchanged.

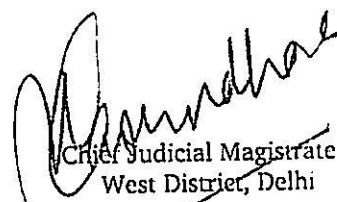
