## ORDER

It has been brought to the knowledge of the undersigned that the cases in which Municipal Corporation of Delhi (MCD) and Delhi Development Authority (DDA) are the parties, such cases are being tried by the different courts of West District which is totally uncalled for.

This is to inform that already court of Ld. JMFC-01 (West) is looking after the criminal cases in which Municipal Corporation of Delhi (MCD) and Delhi Development Authority (DDA) are the parties. Accordingly, all such criminal cases pending in other Courts of JMFCs of West District in which the MCD and DDA are the parties, are required to be tried by the Court of Ld. JMFC-01 (West).

Similarly, the civil cases in which the Municipal Corporation of Delhi (MCD) is a party, such civil cases are to be tried by the Court of Ld. JSCC/ASCJ/GJ-01 and Ld. JSCC/ASCJ/GJ-02. Furthermore, the civil cases in which the Delhi Development Authority (DDA) is a party, such civil cases are required to be tried by the Court of Ld. Civil Judge-02 (West).

Accordingly, it is ordered that the criminal cases in which Municipal Corporation of Delhi (MCD) and Delhi Development Authority (DDA) are the parties, be transferred to the Court of Ld. JMFC-01, West District.

Furthermore, it is ordered that the civil cases in which the Municipal Corporation of Delhi (MCD) is the party, be transferred to the Court of Ld. JSCC/ASCJ/GJ-01 and Ld. JSCC/ASCJ/GJ-02 duly forwarded by the Ld. SCJ/RC (West) and the civil cases in which the Delhi Development Authority (DDA) is the party, be transferred to the Court of Ld. Civil Judge-02, West District, duly forwarded by the Ld. SCJ/RC (West).
